Approximately six rotating exhibits on a variety of topics are offered each year in the museum's special exhibits gallery.

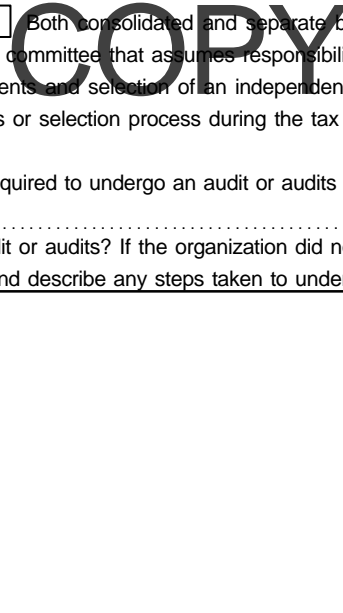
